## CONDITIONS OF ENTRY

1. Entries must be presented in a clean, complete and safe working condition.
2. The Road Traffic Act now applies to all places where the public have access. All vehicles must be insured against third party risks as required by law. No driving under the influence of drink or drugs and no unlicensed or under age driving.  
The organisers reserve the right to ask for proof of insurance.
3. No exhibit is to be left running without a controller present.
4. All vehicles should be safely parked and securely braked.
5. A speed limit of 10 m.p.h. shall apply to all vehicles.
6. Exhibitors must pay proper regard to the marshals instructions and conduct themselves in a manner which will not inconvenience other persons on the Rally Field.  
The organisers reserve the right to ask persons to leave the Rally Field in the event of serious breaches of the regulations, misconduct, or for any other reason which may be pertinent to the good running of the Rally.
7. The organisers reserve the right to restrict entries if need be.
8. **Vehicles without a pass displayed in the windscreen will be charged the full Bewl Water parking rate and not guaranteed a space on the rally field.**
9. Entries received after May 1st 2019 may not be included in the complimentary programme or judged in the concours competition.
10. No unauthorised trading, of any kind, from vehicles on the rally field, other than official autojumblers etc., is permitted. Autojumble plots are available.

***An area next to the Rally Field has been reserved for trailers and their tender vehicles.  
Please unload any exhibits there and not on the Rally Field.***

Please ensure that you include the correct size stamped and addressed envelope, preferably a 9" x 4". Anything larger than an A5 (160mm x 230mm, 6 3/8" x 9") envelope is unnecessary and **requires additional postage**. Please do not send very small stamped and addressed envelopes for return of entry passes as this makes it difficult to get the paperwork in.
